An analysis of **Gregson v H.A.E. Trustees Ltd** [2008] EWHC 1006 (Ch)

Should aggrieved beneficiaries of a trust be entitled to recover damages from the directors of their trustee company, where they can point to a breach by those directors of their duty of care to the company itself, on the basis that a corporate trustee's claims against its directors are held on trust for the trusts it administers, (which have become known as "dog leg claims")?
